



# Metaphysical Anatomy Level 2 Practitioners Certification Program

Welcome to Level 2 Practitioners Certification Program!

## About the Program

The Certification Program is for Level 2 Metaphysical Anatomy Students wanting to enhance their skills and become more proficient Practitioners. This Program have been made to be more knowledgeable, exciting, flexible, interactive, and effective. The program allows you to enhance your skills anywhere, anytime and within a reasonably flexible schedule. After completing the program, the student will receive a Certification Program certificate (**Level 2 MAT Certified Practitioner**) from Metaphysical Anatomy signed by Evette Rose.

## Certification Framework

Certification program is divided into two parts, the **Knowledge** and **Practice** section. Both should be completed concurrently and within the 6-month certification period. The knowledge section of the Certification program includes Level 2 refresher online course, webinars, videos, and any learning material that may be added later. The Cases need to be done within the time frame.

The **Knowledge** Part of the Certification Program will consist of the following:

- Qualified: Must be done and completed MAT Level 1 Certification Program.
- Study: Attend and Understand Level 2 Teachings and Technique
- Nourishment: Attend Level 2 refreshment course online.
- Assisting in 2 Level 2 courses as assistant with his Level 2 teacher
- Strengthen: Gain and strengthen knowledge by watching and understanding Level 2 Webinar replays.



- Ethics: Understand & Practice Ethics & MAT Code of Conduct.
- Test: Test your knowledge and expertise by taking the Certification Exam.

The **Practical** section of the certification Program involves developing individual Practicing healing abilities and includes submission of 12 successfully healed cases using Metaphysical Anatomy Level 2 Technique Only. This includes 3 simple Physical Healing cases, 2 severe or chronic Physical Illness Healing cases, 5 Emotional Healing cases, and 2 Womb Healing. All cases must be reviewed and approved by your mentor (Teacher).

## Course Requirements

To successfully complete the program, candidates must meet the following requirements within [Six Months of their Application](#):

- Successful completion of all Knowledge Part.
- Assisting in 2 MAT Level 2 Courses
- Completion of 12 healing cases. All cases must be reviewed and approved by your mentor (teacher).
- Completion and passing of Exam
- Submission of a portfolio that includes completed Clients Session Sheet and mentor-approved 12 healing cases.

If the Applicant Fail to meet the requirement, they can re-apply for the program again in one month.

## Points to Consider:

Here are some points to be Considered During your Course of Certification:

- You can't apply for Level 2 Certification Program & Level 1 Certification Program at the same time, you must finish the Level 1 Certification Program first before Applying for the Level 2 Certification Program.



- Attending & Studying MAT Level 2 course has nothing to do with your Level 1 Certification Program, you can study level 2 even before finishing your level 1 Certification.
- You are allowed to finish your Level 1 certification first and will be exempted from the six-month application period for Level 2.
- Sessions with MAT Students or during healing Swaps can be included in cases.
- Sessions with Family members can also be used for the certification program.
- Non-English speakers who are not able to take the prerecorded online refresher course can join live or live online Level 2 course with their teacher/mentor as an alternative.
- For Assisting in live and live online courses: If your Level 2 teacher is no longer teaching or doesn't have courses during your certification program, you can assist another teacher. Please make sure to inform your mentor so they can endorse you properly.
- Meet your Mentor at least once a month to monitor your progress and help you in answering your Questions.
- Attending Webinars Hosted by Evette Rose will enhance and improve your knowledge.
- Attending Regular Healing Swaps Hosted by MAT or your Teacher will improve your skills.
- Mentor Must be MAT Level 2 Teacher.

## **Mentoring Program**

The Mentoring Program offers extra support from the teacher to his students who wanted to be Certified Practitioners, to provide guidance and encouragement aimed at developing MAT proficiency and competence to you, the Metaphysical Anatomy candidate/mentee.

- You will be assigned to your Level 2 teacher to be your mentor for the program (or another level 2 teacher if your teacher is not available).
- You will need to contact your mentor within 1 week of receiving your program application approval and get to meet him with the Mentee meeting for guidance and



schedule.

- You and your mentor will set up a meeting schedule together with Mentee group for the duration of the program. your mentor will provide support and guidance as you complete your knowledge & healing cases. You are expected to have at least 1 face-to-face meeting (in- person, Skype, Zoom, etc.) with your mentor.

Being a mentor and a mentee will require diligence – there is a compelling need to commit to regular meetings (and actually meet), outline progress, and learn to operate a new relationship with imperturbability.

## Policies and Procedures

**Dismissal from program:** Candidates must be actively engaged in making progress towards his/her certification and meeting program progress & requirements. Failure to achieve progress will lead to performance review, which may result in dismissal from program.

**Drop out from Program:** Candidates who wish to officially drop out from the MAT Certification Practitioners program must submit a formal letter to their mentor and [info@metaphysicalanatomy.com](mailto:info@metaphysicalanatomy.com). Candidate will not be eligible for any refund.

**Request for Extensions:** The program ends in six months from the date the application is approved. No extensions will be granted, unless explained serious circumstances & upon mentor approval & final approval of MAT Admin.
